

## RULES AND CONDITIONS OF LEASE OF CAR WITHOUT DRIVER OF "ATON" CO LTD

Service of lease of car without driver (hereinafter referred to as Car lease) is rendered to physical and legal persons.

1. **ORDER of SERVICE.** Order of car can be made any day of the week from 09:00 till 21:00 using phone +7(8622) 960-331, +7(918) 400-4860 e-mail: [zakaz@at-on.ru](mailto:zakaz@at-on.ru).
2. **REQUIREMENTS to LEASEHOLDER.** Driver has to be not younger than 20 years old and driving experience not less than 2 years
3. **NECESSARY DOCUMENTS.** For receipt of car it is necessary to grant the following documents: passport and a valid driving license.
4. **POWER of ATTORNEY.** At car lease only one power of attorney is issued. For each additional power of attorney extra payment is raised from the Client according to the current rates of the Company.
5. **COST of SERVICES.** All rates include maintenance service of the car for all term of rent (except for washing and fuelling and also the penalties paid by the Leaseholder in case of violation of Traffic Rules), insurance of responsibility before a third party and insurance for risks of "Damage" and "Car theft".
6. **PAYMENT of SERVICES.** Payment for car lease is made both in cash and non-cash way at the rate of 100% from cost of services.
7. **GUARANTEE SUM (MORTGAGE).** At the conclusion of the contract of car lease the Client obliges to deposit a guarantee sum according to the current rates of the Company.
8. **INSURANCE of CARS.** All cars are insured for risks with compulsory civil liability motor-vehicle insurance, "Car theft + damage" and the cost of insurance is included in the cost of car lease.
9. **DELIVERY and RETURN of CAR.** Cars are delivered to Clients either at the office of the Company or in any other place of Sochi at will of the Client. Cars also are delivered and returned at the airport. For delivery of car extra payment is raised according to the current rates of the Company.
10. **KILOMETRAGE LIMIT.** Kilometrage limit of the car is up to 300 km per day. In case of excess of kilometrage limit for the term of car lease the Client pays the difference between the actual kilometrage and the limit according to the current rates of the Company.
11. **RESTRICTIONS ON MOVEMENTS.** Cars are leased exclusively for Krasnodar territory.
12. **PERIOD OF CAR LEASE AND DELAY OF RETURN OF CAR.** The car is leased by the day. A day is equal to 24 hours. The Client obliges to return the car from 09:00 till 21:00. In case of delay of return of the car the Client is obliged to inform the Company on it. In case of delay for more than 2 hours the Client obliges to pay the cost of day lease of vehicle to the Lessor.
13. **REFUELLING and WASHING of CAR.** Cars are leased clean, with a full tank of fuel and are to be returned by the Client at observance of the set of the above-mentioned conditions. At return of unwashed car or with not a full tank of fuel the Client obliges to pay the car washing and the missing quantity of fuel according to the current rates of the Company.
